Dear all,

Wellington Town Council, will hold its Full Council Meeting on Tuesday, 12<sup>th</sup> October 2021, starting at 6.15pm.

This meeting will be held in the Council Chamber at Civic Offices and potentially we will be unable to adequately socially distance from each other as there could be in excess of 24 people in the room. Therefore, in order to do as much as we can to reduce the risk of the transmission of COVID infection and try to keep everyone as safe as possible, we need to ask every one attending to comply with the following;

- 1) If you have any COVID symptoms please do not attend this meeting
- 2) Please provide evidence that you are double jabbed if you have not already done so
- 3) Please bring with you proof of a negative lateral flow test taken within the previous 24 hrs prior to the meeting ( test kits will be available in Lesley's room on the evening but you will need to arrive 30 minutes before the start of the meeting in order to take the test and allow time for it to work). Test kits are also available free of charge from the Library / Chemists or via request through the post.
- 4) Please wear a mask for the duration of the meeting
- 5) Please sanitise your hands as you enter the room (sanitiser bottle fixed next to door frame)
- 6) Windows and doors will be open to allow a circulation of air
- 7) All seats and tables will be sanitised prior to and after the meeting
- 8) No papers will be handed out
- 9) No refreshments will be available
- 10) Entry and exit will be via the Leisure Centre reception

We are aware that numbers of COVID infection rates are rising in our area so if you are unable to comply with the above requirements please do not attend this meeting. We reserve the right to refuse entry.
